- Pee Wee – 10 yrs and under as of January 1ST may not cross-enter into **Beginner, Youth or Open, W/T only**
- Beginner – 12 yrs and under as of January 1ST – may not cross-enter into **Pee-Wee, Youth or Open, No gait restrictions**
- Youth - 18 yrs and under as of January 1ST
- Open Barrels – 50 entries or under \$300 added. 51-74 entries \$500 added. 75 and over \$700 added.
- Open and youth poles must have 25 or more entries or added money will be decreased
- Any roll-overs must be declared before the first horse runs in the Open division

Coggins and Rabies are required for every horse on the grounds within 12 months
